A NEGOTIATED
COST-REIMBURSEMENT SUBCONTRACT
WITH
EDUCATIONAL INSTITUTIONS
FAR 52.252-2, CLAUSES INCORPORATED BY REFERENCE (FEBRUARY 1998)**

******(Include in subcontracts that exceed \$100,000, except for paragraph (c)(1) of the clause.) ******

52.203-7 Anti-Kickback Procedures (JULY 1995)

******(Include in subcontracts that exceed \$100,000.) ******

52.203-12 Limitation on Payments to Influence Certain Federal Transactions (SEPT 2007)

******(Include the following in all subcontracts greater than \$5,000,000 with a performance period of more than 120 days except for commercial items and work performed entirely outside the United States.) ******

52.203-13 Contractor Code of Business Ethics and Conduct (DEC 2007)

52.203-14 Display of Hotline Poster(s) (DEC 2007)

******(Include in all subcontracts when the subcontractor is required to have routine physical access to a Federally-controlled facility and/or routine access to a Federally-controlled information system.)******

52.204-9 Personal Identity Verification of Contractor Personnel (SEPT 2007)

******(Include in subcontracts that exceed \$100,000.) ******

52.215-2 Audit and Records - Negotiation (JUNE 1999), Alternate II (APRIL 1998)

******(Include when it is contemplated that cost or pricing data will be required from the subcontractor and the action exceeds \$550,000.) ******

52.215-10 Price Reduction for Defective Cost or Pricing Data (OCTOBER 1997)

******(Include when it is contemplated that cost or pricing data will be required from the subcontractor, the action exceeds \$550,000 and FAR 52.215.10 has not been included.)******

52.215-11 Price Reduction for Defective Cost or Pricing Data – Modifications (OCTOBER 1997)

******(Include in subcontracts that contain FAR 52.215.10.) ******

52.215-12 Subcontractor Cost or Pricing Data (OCTOBER 1997)

******(Include in subcontracts that contain FAR Clause 52.215-11.) ******

52-215-13 Subcontractor Cost or Pricing Data - Modification (OCTOBER 1997)

******(Include in subcontracts if it is anticipated that cost or pricing data will be required or for which any preaward or postaward cost determination will be subject to Subpart 31.) ******

52.215-15 Pension Adjustment and Asset Reversions (OCTOBER 2004)

******(Include in subcontracts if it is anticipated that cost or pricing data will be required or for which any preaward or postaward cost determination will be subject to Subpart 31.) ******

52.215-18 Reversion or Adjustment of Plans for Post-Retirement Benefits (PRB) other than Pensions (July 2005)

******(Include if the subcontract exceeds \$100,000 and offers subcontracting opportunities.) ******

52.219-8 Utilization of Small Business Concerns (MAY 2004)

******(Include if the subcontract exceeds \$500,000 and offers subcontracting opportunities.) ******

52.219-9 Small Business Subcontracting Plan (APRIL 2008`)

******(Include if the subcontract includes 52.222-26)******

52.222-21 Prohibition of Segregated Facilities (FEBRUARY 1999)

******(Include in all subcontracts.) ******

52.222-26 Equal Opportunity (MARCH 2007)

******(Include in subcontracts of \$25,000 or more unless exempted by rules, regulations, or orders of the Secretary of Labor.) ******

52.222-35 Equal Opportunity for Special Disabled Veterans and Veterans of the Vietnam Era, and other Eligible Veterans (SEPT 2006)

******(Include in subcontracts that exceed \$10,000 unless exempted by rules, regulations, or orders of the Secretary of Labor.) ******

52.222-36 Affirmative Action for Workers with Disabilities (JUNE 1998)

******(Include in subcontracts of \$25,000 or more unless exempted by rules, regulations, or orders of the Secretary of Labor.)******

52.222-37 Employment Reports on Special Disabled Veterans and Veterans of the Vietnam Era (SEPT 2006)

****** (Include in all subcontracts) ******

52.222-50 Combating Trafficking in Persons (AUGUST 2007)

****** (Include in all subcontracts.) ******

52.225-13 Restrictions on Certain Foreign Purchases (JUNE 2008)

****** (Include in all subcontracts expected to exceed \$100,000.) ******

52.227-1 Authorization and Consent (DEC 2007)-Alternate I (APRIL 1984)

****** (Include in all subcontracts expected to exceed \$100,000.) ******

52.227-2 Notice and Assistance Regarding Patent and Copyright Infringement (DEC 2007)

****** (Include in all subcontracts for experimental, developmental or research work that will be performed by a small business firm or a domestic nonprofit organization.) ******

52.227-11 Patent Rights - Ownership by the Contractor (DEC 2007)

****** (Not specifically required to be included in subcontracts; however, the Contractor has the responsibility to obtain from its subcontractors all data and rights therein necessary to fulfill the Contractor's obligations to the Government under the contract.) ******

52.227-14 Rights in Data - General (DEC 2007) Alternate IV (DEC 2007)

****** (Include in all subcontracts for supplies or services other than commercial items.) ******

52.244-6 Subcontracts for Commercial Items (MARCH 2007)

****** (Not specifically required in subcontracts; however, if the Contractor transfers Government property to the subcontractor, the subcontract shall contain provisions that either relieve the subcontractor from liability for loss or destruction of, or damage to the property, or requires the return of all Government property in good condition.******

52.245-1 Government Property (Cost-Reimbursement, Time and Material, or Labor-Hour Contract (JUNE 2007).

******(Include in all subcontracts. The relationship between the Contractor and subcontractor should be clearly indicated. Inapplicable conditions (e.g., paragraph (h) should be deleted, and the period for submitting the subcontractor's termination settlement proposal should be reduced.)******

52.249-5 Termination for the Convenience of the Government (Educational and Other Nonprofit Institutions) (SEPTEMBER 1996)
